What are the legal requirements for personal protective equipment? Although there is no general requirement in the Ministry of Labour's legislation for an employer to provide workers with personal protective equipment (PPE), an employer has a general duty, under OHS Act Section 25(2)(h) to "take every precaution reasonable in the circumstances" to protect workers.
