Medical malpractice claims have a 2-year statute of limitations, which is the time period within which a plaintiff must file a lawsuit. Generally, the 2-year period begins to run from the date of the treatment in question.

A one-standard-deviation increase in the number of payments per physician causes a 2.2 percent decrease in physician workforce, while a one standard deviation increase in payment size decreases workforce by 1.2 percent.

The physician or medical office is responsible for the malpractice of its staff, whether employed directly by them (doctrine of respondeat superior) or employed by a temporary agency (borrowed servant).
