Today, the fee tail can only be created in Delaware, Maine, Mass., and Rhode Island, and can be terminated by the tenant in possession transferring fee simple to another. (But it cannot be terminated by will.) While not greatly significant in today's practice, fee tail still shows up prominently on the Multistate Bar Exam.

Under the Estate system, there was also an interest, called the "fee tail" that was a fee interest, in that it had the possibility of lasting forever, but that was a lesser interest than a fee simple.

A fee tail can endure until the holder dies without surviving issue, but it cannot be passed on to collateral

heirs. A reversion remains in the original owner whenever a fee tail is created. Thus, if a tenant in fee tail dies without heirs, the property reverts back to the original grantor who initially created the fee tail estate.

Enforceability of Tail Fee Provision in Engagement Letter

In Ireland, section 13 of the Land and Conveyancing Law Reform Act 2009 abolished the fee tail in Ireland and converted existing fees tail to fees simple. For constitutional reasons, this section is subject to a saving clause which prevents the conversion of fees tail to fees simple where the protector of the settlement is still alive.
